### Annual Report for the year ending 30 June 2020

#### Details of scheme

The following details relate to the scheme as at 30 June 2020:

- a) The name of the scheme is Students Education Fund (New Zealand) herein referred to as the "scheme"
- b) The scheme is a managed investment scheme
- c) Futurity Investment Group Limited is the manager of the scheme
- d) Covenant Trustee Services Ltd is the Supervisor of the scheme
- e) The latest PDS for Students Education Fund (New Zealand) No.2 is dated 1 March 2018 and is closed to new investors; there is no PDS for Students Education Fund (New Zealand) No.1 lodged with the Registrar as in addition to the offer being closed to new investors, contributions are no longer accepted
- f) Fund updates for the quarter ending 30 September 2020 were made publicly available on 5 November 2020
- g) The latest financial statements and auditor's report for the period 30 June 2020 have been lodged with the Registrar

#### Changes relating to the scheme

The manager of the scheme changed name from Australian Scholarships Group Friendly Society Limited to Futurity Investment Group Limited on 29 November 2019.

While there were no other changes in the reporting period, amendments to the Statement of Investment Policy and Objectives were approved on 17 August 2020 to reflect the name change as well as some minor amendments to the Investment Committee triggers and investment manager selection criteria.

As outlined in the SIPO, due to the minimal total value of funds under management, it is no longer possible to adhere to the permitted Asset Allocation Ranges as outlined in the Rules of the Fund. Both the Statutory Supervisor and APRA (the Australian Regulator) have been notified. A plan is being developed in consultation with APRA to address this issue as part of a broader organisation-wide initiative. Futurity has been aware of this issue for some time and continues to monitor it carefully.

There were no related party transactions during the accounting period.

There have been no other material changes to the governing documents or the terms of the offer (now closed to new investors).
